 - e. Code Enforcement – Mr. Musso made the motion to appoint Daniel Shaw; seconded by Mrs. Kabacinski. All were in favor.
6. **Vacancy Board** – Mr. Klinedinst made the motion to appoint Javier Rodriguez to the position; seconded by Mr. Henshaw. All were in favor
7. **Solicitor** – Mr. Musso made the motion to appoint Mike Craley, Esquire, to the position; seconded by Mrs. Frutiger. All were in favor.
8. **Zoning Solicitor** – Mr. Musso made the motion to appoint Gavin Markey, Esquire, to the position; seconded by Mrs. Frutiger. All were in favor.

9. **Signatures on Checks** – Mr. Musso made the motion to authorize all council members to sign the checks; Mrs. Frutiger seconded. All were in favor.
10. **Auditors** – Mr. Klinedinst made the motion to appoint Stambaugh Ness as auditors for all Borough Accounts; seconded by Mrs. Frutiger. All were in favor.
11. **Engineer** – Mr. Musso made the motion to appoint CS Davidson to the position; seconded by Mrs. Frutiger. Mr. Klinedinst opposed. Motion carried.
12. **York Adams Tax Bureau** –Mrs. Frutiger made a motion to appoint Jennifer Gunnet, Windsor Township to represent Red Lion Borough on the YATB, with Kelly Henshaw as the alternate; seconded by Mr. Musso. All were in favor.
