**AN ORDINANCE OF RED LION BOROUGH, YORK
COUNTY, PENNSYLVANIA, AMENDING SECTION 13-105
OF THE CODE OF ORDINANCES OF THE BOROUGH OF
RED LION TO AMEND REQUIREMENTS FOR TRANSIENT
RETAIL MERCHANTS; AND PROVIDING AN EFFECTIVE DATE**

BE IT ENACTED AND ORDAINED by the Council of the Borough of Red Lion, and it is hereby enacted and ordained, that the Code of Ordinances of the Borough of Red Lion, is amended as follows:

SECTION 1: Section 13-305 is hereby amended to delete existing language and replace it to read as follows:

1. Transient Retail Merchants shall not:
 - A. Sell any product or type of product not mentioned or approved in the license issued.
 - B. Engage in such transient retail business on a door to door or house to house basis before 9:00 a.m. or after 7:00 p.m. Monday through Saturday.
 - C. Engage in such transient retail business on a door to door or house to house basis anytime on a Sunday or Holiday.
 - D. Engage in such transient retail business upon any street, alley, sidewalk or public area before 9:00 a.m. or after 9:00 p.m.
 - E. Engage in such transient retail business from a fixed location on any R-O or R-T Zoned Property.
 - F. Engage in such transient retail business on property owned by the Borough of Red Lion or during any activity sponsored or operated by Red Lion Borough or the Red Lion Recreation Department without authorization of the sponsor or operator.
 - G. Use any loudspeaker, horn or other audio or amplification device without authorization of the sponsor or operator.
 - H. Operate in any way to create noxious or offensive odors or fumes.
 - I. Operate generators or music without authorization of the sponsor or operator.
 - J. Operate flashing lights.
 - K. Sell any garage sale, second hand, used or flea market merchandise.
 - L. Store trash that is not bagged or placed in a dumpster.
 - M. Perform tattoos, body piercing or other body artistry except face painting without authorization of the sponsor or operator.
 - N. Sell alcoholic beverages without authorization of the sponsor or operator.
 - O. Sell items other than homegrown items on farmwagons.

SECTION 2. A new Section 13-305A is hereby added to read as follows:

1. A Transient Retail Merchant engaging in such activity from a fixed location on private property on a temporary basis may operate the transient retail business during the term of the license seven days a week between the hours of 9:00 a.m. and 9:00 p.m.
2. All Transient Retail Merchants shall at all times display all current governmental licenses and inspection reports.
3. All Transient Retail Merchant licenses shall be valid for not more than six (6) months from the date of issuance.

SECTION 3. This Ordinance shall become effective immediately upon enactment and approval.


