

**ORDINANCE NO. 2025-8-1
RED LION BOROUGH
YORK COUNTY, PENNSYLVANIA**

AN ORDINANCE OF RED LION BOROUGH, YORK COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 OF THE CODE OF ORDINANCES OF THE BOROUGH OF RED LION TO PROVIDE A DEFINITION OF "PARKING SPACE"; TO PROHIBIT PARKING UPON ANY STREET OR PART OF A STREET DESIGNATED WITH TEMPORARY NO PARKING SIGNS FOR STREET SWEEPING; TO PERMIT USE OF CREDIT CARDS AND OTHER METHODS OF PAYMENT FOR PARKING METERS; TO PERMIT KIOSKS AND OTHER DEVICES TO SERVE AS PARKING METERS FOR PAYMENT; TO ESTABLISH A 15 MPH SPEED LIMIT ON LOCUST LANE; PROHIBITING TRUCKS 25' OR GREATER FROM MAKING TURNS AT CERTAIN DESIGNATED INTERSECTIONS; TO MAKE LOCUST LANE ONE-WAY BETWEEN NORTH FRANKLIN STREET AND NEFF STREET; TO MAKE NEFF STREET ONE-WAY BETWEEN WEST BROADWAY AND SUMMIT LANE AND ALSO BETWEEN LOCUST LANE AND MAPLE STREET; ESTABLISHING STOP INTERSECTIONS AT PLEASANT VIEW STREET AT EAST LANCASTER STREET AND ON CHURCH LANE AT WINDSOR LANE; PROHIBITING PARKING OF VEHICLES ON BOTH SIDES OF LOCUST LANE BETWEEN NORTH FRANKLIN STREET AND NEFF STREET, ON BOTH SIDES OF NEFF STREET BETWEEN ATLANTIC AVENUE AND THE END, ON THE WEST SIDE OF NORTH FRANKLIN STREET FROM THE NORTH SIDE OF MAPLE STREET TO A POINT 42 FEET NORTH THEREFROM, ON BOTH SIDES OF LEMON LANE FROM EAST AVENUE TO NEWTON LANE; CHANGING THE METERED PARKING RATE TO \$0.25 FOR 60 MINUTES; ESTABLISHING METERED PARKING ON THE WEST SIDE OF NORTH FRANKLIN STREET BETWEEN CHERRY STREET AND LOCUST LANE; ELIMINATING EXISTING MUNICIPAL PARKING LOTS AND ESTABLISHING THE LOT AT 33 WEST BROADWAY AS A MUNICIPAL PARKING LOT; DELETING SECTION 15-926 IN ITS ENTIRETY; DELETING EAST ELM LANE FROM PLEASANT VIEW STREET TO THE BOROUGH LINE FROM STREETS ADOPTED BY ORDINANCE 971-7; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

BE IT ENACTED AND ORDAINED by the Council of the Borough of Red Lion, and it is hereby enacted and ordained, that the Code of Ordinances of the Borough of Red Lion, is amended as follows:

SECTION 1: Section 101.4 is hereby amended to add the following definition:

PARKING SPACE – An on or off street space 10’ x 20’ delineated by markings for the parking of one motor vehicle and having direct usable access to a street or lane.

SECTION 2: Section 15-311 is hereby amended to read as follows:

No person shall park a vehicle or allow the same to remain parked upon any street or part of any street which is posted with temporary signs designating no parking for street sweeping.

SECTION 3: Sections 15-602 and 15-604 are hereby amended to add the following sentence at the end:

The use of the term “coin” in these Sections and anywhere else in this Part shall also include the use of credit cards, online digital parking payment service applications as approved by Red Lion Borough Council, and any other form of payment which may be approved by Red Lion Borough Council.

SECTION 4. Section 15-603 is hereby amended to add the following sentence at the end:

The use of the term “parking meter” in this Section and anywhere else in this Part shall also include any kiosk or other device placed on or near the parking space or within a parking lot for the use of cash, credit cards, online digital parking payment service applications as approved by Red Lion Borough Council, and any other form of payment which may be approved by Red Lion Borough Council.

SECTION 5: Section 15-901 of the Code of Ordinances is hereby amended to add the following speed limit:

Name of Street	Speed Limit (mph)	Location
Locust Lane	15	From North Franklin Street To Neff Street

SECTION 6: A new Section 15-904A. is added to the Code of Ordinances as follows:

s. 15-904A. Schedule IV-I: Prohibited Turns at Intersections.

In accordance with the provisions of s.15-204, no driver of any truck 25 feet and greater in length shall make a turn of the kind designated below at any of the following intersections:

Name of Street	Direction of Travel	Prohibited Turn	At Intersections of
East Broadway	East	Right	South Boxwood Road
West Broadway	East	Left	Neff Street
West Broadway	West	Right	Neff Street

SECTION 7: Section 15-906 of the Code of Ordinances is hereby amended to add the following one-way streets:

Name of Street	Direction of Travel	Hours/Days	Limits
Locust Lane	West	All/All	From North Franklin Street To Neff Street
Neff Street	North	All/All	From West Broadway to Summit Lane
Neff Street	South	All/All	From Locust Lane to Maple Street

SECTION 8: Section 15-909 of the Code of Ordinances is hereby amended to add the following Stop intersection:

Stop Sign On	Direction of Travel	At Intersection of
Pleasant View Street	Both	East Lancaster Street
Church Lane	West	Windsor Lane

SECTION 9: Section 15-916 of the Code of Ordinances is hereby amended to add the following no parking at all times:

Name of Street	Side	Location
Lemon Lane	Both	From East Avenue to Newton Lane
Locust Lane	Both	From North Franklin Street To Neff Street
North Franklin	West	From Maple Street to a point 42 feet north therefrom
Neff Street	Both	Atlantic Avenue north to the end

SECTION 10: Section 15-923 of the Code of Ordinances is hereby amended to change the rate to 60 minutes/0.25.

SECTION 11: Section 15-923.1 of the Code of Ordinances is hereby amended to add the following Parking Meter Zone:

Name of Street	Side	Time Limit/Rate	Location
North Franklin Street	West	60 minutes/\$0.25	From Cherry Street To Locust Lane

SECTION 12: Section 15-924.1 of the Code of Ordinances is hereby amended delete existing parking lots and add the following:

- A. Red Lion Municipal Lot at 33 West Broadway

SECTION 13: Section 15-926 of the Code of Ordinances is hereby deleted in its entirety.

SECTION 14: Sub-Section (2) of Section 1 of Ordinance 971-7 which opened, widened and adopted East Elm Lane from Pleasant View Street to the Borough line is hereby repealed and deleted.

SECTION 15: The provisions of this Ordinance are severable and if any section, sentence, clause or part or provision hereof shall be held to be illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect the remaining sections, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough of Red Lion that such ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION 16. Nothing contained in this ordinance shall be construed to affect any suit or proceeding in any court, or any rights acquired, or liability incurred, or any cause or action existing prior to the enactment of this Ordinance.

SECTION 17. This Ordinance shall become effective immediately upon enactment and approval.
