**AN ORDINANCE OF RED LION BOROUGH, YORK  
COUNTY, PENNSYLVANIA, AMENDING SECTION 13-302  
OF THE CODE OF ORDINANCES OF THE BOROUGH OF  
RED LION TO AMEND REQUIREMENTS FOR TRANSIENT  
RETAIL MERCHANTS; AND PROVIDING AN EFFECTIVE DATE**

**BE IT ENACTED AND ORDAINED** by the Council of the Borough of Red Lion, and it is hereby enacted and ordained, that the Code of Ordinances of the Borough of Red Lion, is amended as follows:

**SECTION 1:** Section 13-301 is amended to add the following definition:

MULTI-VENDOR EVENT- an event attended by more than one (1) vendor.

ORGANIZER- The Person responsible for allocation of space and registration of vendors for a multi-vendor event.

**SECTION 2:** Section 13-302.1 is hereby amended to add the following language at the end:

For all Multi-Vendor Events, the organizing person or person authorized by the organizing entity must apply for the license.

**SECTION 2:** Section 13-302.2 is hereby amended to delete existing all existing language and is amended to read as follows:

2. Licenses and exemptions from licensing shall be set forth as follows:

A. Independent Vendors:

D. Events sponsored or organized by Red Lion Borough or the Red Lion Area School District shall be exempt from licensing requirements. In the event of any question concerning this exemption, the Borough Manager shall have the authority to grant permission for the event and exempt the fee.

**SECTION 3.** This Ordinance shall become effective immediately upon enactment and approval.
