

**ORDINANCE NO. 2018-9-5
RED LION BOROUGH
YORK COUNTY, PENNSYLVANIA**

**AN ORDINANCE OF RED LION BOROUGH, YORK
COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15
OF THE CODE OF ORDINANCES OF THE BOROUGH OF
RED LION TO PROHIBIT PARKING OF VEHICLES
ON THE SOUTH SIDE OF BOUNDARY AVENUE BETWEEN
LINDEN AVENUE AND ADAMS LANE AT ALL TIMES;
PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING
AN EFFECTIVE DATE**

BE IT ENACTED AND ORDAINED by the Council of the Borough of Red Lion, and it is hereby enacted and ordained, that the Code of Ordinances of the Borough of Red Lion, adopted on September 14, 2009 by Ordinance 2009-09-02 is amended as follows:

SECTION 1: Section 15-916 of the Code of Ordinances is hereby amended to add the following to the areas which prohibit parking of vehicles at all times:

Name of Street	Side	Location
Boundary Avenue	South	From Linden Avenue To Adams Lane

SECTION 2: Section 15-917 of the Code of Ordinances is hereby amended to delete the following to the areas which prohibit parking of vehicles at certain times:

Name of Street	Side	Hours/Days	Location
Boundary Avenue	South	7:00 a.m. to 4:00 p.m./ Monday through Friday	From Linden Avenue to Adams Lane

SECTION 3. The provisions of this Ordinance are severable and if any section, sentence, clause or part or provision hereof shall be held to be illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect the remaining sections, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough of Red Lion that such ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION 4. Nothing contained in this ordinance shall be construed to affect any suit or proceeding in any court, or any rights acquired or liability incurred, or any cause or action existing prior to the enactment of this Ordinance.


SECTION 5. This Ordinance shall become effective immediately upon enactment and approval.


